



Educational sessions include *“How the Mind Decides: How Judges and Jurors Make Decisions”*, which will be presented by Mr. Todd Winegar, Esq., one of America’s highest rated CLE speakers. Following Mr. Winegar’s presentation will be an in-depth panel discussion with former jurors and a review of significant proposed changes to jury management in Federal Courts. Our guest luncheon speaker, Mr. Barry Levenson, Esq., curator of the Mount Horeb Mustard Museum and a past guest of the Oprah Winfrey Show and the Food Network, will discuss *“When Oreos are Outlawed, Only Outlaws Will Eat Oreos: Law as an Instrument of Healthy Eating; Can We Stomach It?”*.
