**ORDER OF APPOINTMENT**

10 Pursuant to the provisions of 28 U.S.C. § 546, the Attorney General of the United States  
11 appointed Dayle Elieson as United States Attorney. Under 28 U.S.C. § 546(c), “[a] person  
12 appointed as United States attorney under this section may serve until the earlier of (1) the  
13 qualification of a United States attorney for such district appointed by the President under  
14 section 541 of this title; or (2) the expiration of 120 days after appointment by the Attorney  
15 General under this section.” Under 28 U.S.C. § 546(d), if an appointment expires under  
16 § 546(c)(2), the district court for such district may appoint a United States attorney to serve  
17 until the vacancy is filled.

18 The Court is advised that Dayle Elieson’s 120-day appointment will expire on May 4,  
19 2018. The Court is further advised that the nomination and confirmation process will not be  
20 completed by May 4, 2018, and that it is necessary, therefore, for the Court to appoint a United  
21 States attorney, effective May 5, 2018.


22 Accordingly,

23 **IT IS HEREBY ORDERED** that pursuant to 28 U.S.C. § 546(d), the Court, by a  
24 unanimous vote, appoints Dayle Elieson to serve as United States Attorney for the District of

1 Nevada, effective May 5, 2018, and to serve in that capacity until the vacancy is filled by the  
2 person nominated by the President and confirmed by the United States Senate.

3 **IT IS FURTHER ORDERED** that this Order of Appointment shall be filed with the  
4 Clerk of Court.
