## Summary of Plan for Resuming Jury Trials October 20, 2020

The United States District Court for the District of Nevada is aware of public health concerns arising over the novel coronavirus, also known as COVID-19, and is deeply committed to the safety and wellbeing of every individual involved in our judicial system. We are closely following and reinforcing the guidelines from the CDC, and local and national health authorities, and have taken precautionary measures to limit the potential spread of the virus while also ensuring that we can continue with essential judicial proceedings—and resume jury trials. What follows is a summary of our plan for resuming jury trials.

#### **Jury Trial Priorities**

- The Court will follow a division-wide trial stack. Only one trial at a time will be conducted in each division.
- All trials will start on Monday mornings. So long as the jury begins deliberating by the end of Friday, the next trial will start on Monday.
- On each trial stack, priority goes to the defendant who has been in custody longest. Second longest in custody gets second priority, etc. Civil jury trials will be scheduled for any open weeks in a stack. In other words, if all criminal cases on a stack resolve or move, any remaining civil cases will be set for trial on that stack.
- A master trial scheduling conference will take place three weeks before the trial start date.
- During the scheduling conference, the presiding judge will notify the parties of their priority ranking based on the master trial list and schedule a trial for each week of the stack.

#### **Jury Selection**

- To expedite voir dire, several of the standard, non-case-specific voir dire questions typically asked in this district will be posed in a new questionnaire that potential jurors must complete online in advance of jury selection. A copy of the questionnaire is attached.
- Amended General Order 2020-10 authorizes jury administrators to grant jury service deferrals (referenced in the jury plan as temporary excuses) for COVID-19-related reasons, and other standard reasons consistent with this district's historical practices.
- Jury questionnaire responses will be provided to counsel the Thursday before trial, and the
  trial judge will likely conduct a hearing on Friday morning to discuss which prospective jurors
  can be excused for cause (clear bias issues, etc.) or temporarily excused based on a jury
  questionnaire response that does not trigger a deferral listed in Amended General Order
  2020-10.
- Those prospective jurors who are either excused for cause or temporarily excused will be notified not to come to court that following Monday when trial starts.

• Jury selection will be conducted in a trial courtroom and an overflow courtroom to ensure sufficient social distancing.

### **COVID-19 Mitigating Measures**

- In the beginning stages, there will be one designated courtroom each in Las Vegas and Reno
  for criminal jury trials. Each will be equipped with plexiglass dividers in the jury box, in front
  of the courtroom deputy and court reporter, on the witness stand, and between the judge
  and staff.
- Temporary General Order 2020-02 restricts individuals who have COVID-19, or may have COVID-19 symptoms, from accessing the courthouses.
- Amended Temporary General Order 2020-08 requires that everyone wear face coverings inside the public areas of the courthouses and during court proceedings, although the presiding judge has discretion to modify this requirement during court proceedings.
- Jurors will have expedited access to go through security screening if they present their summons or juror ID.
- Jurors will be provided with face coverings if they do not have one.
- Elevator usage will be limited to no more than two people at once, and breaks for jurors will take place in designated rooms that accommodate the need for social distancing.
- The public will be allowed into the trial courtroom to the extent that social distancing rules can be implemented.

The court is aware of public health concerns arising over the novel coronavirus, also known as COVID-19, and is deeply committed to the safety and wellbeing of our jurors. We are closely following and reinforcing the guidelines from the CDC and local and national health authorities and have taken precautionary measures to limit the potential spread of the virus while also ensuring that we can continue with essential judicial proceedings. For example, we are taking the following precautions for this trial:

- (1) prospective jurors will respond to some jury-selection questions electronically before reporting to the courthouse to minimize in-court time;
- (2) multiple rooms will be utilized to maintain proper social distancing for the jury-selection process,
- (3) jurors will be separated by plexiglass barriers or seated at least six feet apart from one another during jury selection and trial
- (4) jurors will be required to wear masks or other face coverings, and
- (5) court facilities will be cleaned and sterilized more frequently. Prospective jurors are also encouraged to bring their own personal protective items including face coverings, disinfectant wipes, and hand sanitizer of they wish. Jurors who do not have their own face masks will be given one, and hand sanitizer will be available.

To reduce the amount of time that prospective jurors will need to be in the courthouse for jury selection, the court is asking you to respond to additional screening questions electronically. While these questions ask you to provide personal information, the court and litigants are fully aware of the need to maintain the confidentiality of prospective jurors. The information you provide will be made available to the parties and their lawyers, but not to the press or the public, and will otherwise be kept completely private. If anyone contacts you, attempts to contact you, or appears to be taking any action that could affect your service on this jury, please immediately bring this to the court's attention by calling the jury administrator at (702) 464-5627/ (775) 686-5614.

Serving as a juror is both a privilege and an honor. For more than 200 years, we, as free citizens of this country, have looked to juries to preserve liberty and the independence of the judiciary. **The following information** will help you determine if you must appear for jury service in this case. Please carefully review and promptly follow all instructions on both sides of your summons. If, before your reporting date, you (1) develop flu-like symptoms such as a cough, fever, or shortness of breath; (2) get diagnosed with COVID-19; or (3) have been in contact with anyone who has been diagnosed with a COVID-19 infection, (4) are asked to self-quarantine by a doctor, hospital, or health agency, CALL the jury administrator at (702) 464-5627 / (775) 686-5614 and do not come to the courthouse unless you are specifically instructed to do so after so notifying the court.
