12 **TEMPORARY GENERAL ORDER**
13 **2022-01**

14 The Court has issued a series of general orders changing how the Court operates
15 to do its part in containing the spread of COVID-19.¹ In furtherance of those efforts, on
16 February 10, 2022, the Court adopted, and later amended, a Vaccination Policy for
17 employees and externs in response to the COVID-19 pandemic (“the Policy”) as part of
18 the Court’s gradual transition to living with COVID-19 and resuming normal court
19 operations. See General Order 2022-01. Since then, the Court has incrementally
20 resumed in-person proceedings and expanded jury trials, and recently suspended the
21 face covering requirement for in-person court proceedings. See General Order 2022-
22 02. Nevada Governor Steve Sisolak also recently announced his intention to end the
23 State of Emergency related to the COVID-19 pandemic on May 20, 2022.² Thus, by all
24 indications, society and the Court are transitioning to living with COVID-19 from treating
25 it as an emergency. Accordingly, the Court vacates the Policy and the accompanying
26 General Order 2022-01.

1 That said, COVID-19 continues to circulate in the community, and vaccines
2 remain effective against it.³ The Court continues to encourage all employees and
3 externs to get vaccinated against COVID-19 and stay up-to-date on their vaccinations.

4 It is therefore ordered that General Order 2022-01, First Amended General Order
5 2022-01, and the Policy are vacated.

6 This Order is effective from this 16th Day of May 2022 until further notice.
