The Jury Act, 28 U.S.C. §§ 1865(a) and 1866(c), and Section 4.03 of the District of Nevada's Plan for the Random Selection of Grand and Petit Jurors ("the Jury Plan") allow the Clerk of Court, under supervision of the court, to postpone the reporting date for any person summoned for jury service upon a showing of undue hardship or extreme inconvenience. For purposes of these provisions, IT IS HEREBY ORDERED that the Court deems the following circumstances to be undue hardships or extreme inconveniences for which the Clerk or her Jury Administrators may postpone the reporting date of a summoned juror:

1. Illness or injury on the reporting date;

- Inability to obtain substitute care for child or adult relative requiring care on the reporting date;
- A medical or other appointment that was scheduled before receipt of the juror summons;
- A vacation or other trip that was scheduled before receipt of the juror summons;
- 5. Undergoing or recovering from medical treatment;

- 6. Is a student or teacher who would miss class or other school-related obligations if reporting to appear at the scheduled time, and postponement of service to a scheduled break will eliminate that conflict;
  7. Is scheduled for temporary work out of state;
- 7. Is scrieduled for temporary work out or state,
- 8. Lives in Nevada only part-time and will not be living at Nevada residence on the reporting date;
- Owns a business, will suffer a specific hardship if required to appear on the reporting date, and can provide a substitute date in the near future that will be less problematic;
- 10. Is employed in a seasonal job, will have to miss that temporary work, and postponement of service to a different season will eliminate that conflict;
- 11. Recently started a new job and is in the probationary period;
- 12. Is unable to drive at night, and postponement of service to the summer months will permit juror to avoid night driving; or
- 13. On the reporting date, the summoned juror is experiencing one of the following situations, and that situation is temporary because it is expected to last 30 days or less:
  - a. A temporary lack of transportation; or
  - b. Another temporary work-related, financial, or personal hardship.

IT IS FURTHER ORDERED that U.S. District Judge Jennifer A. Dorsey is appointed under Section 1.03 of the Jury Plan as the supervising judge with the powers granted by the Jury Plan to the Chief Judge.
