INSTRUCTIONS GENERAL

Use. Use this form to order a duplicate audio recording of proceedings. Complete a separate order form for each case number for which audio recordings are ordered.

NOTE: Only proceedings in which the record is taken by digital audio recording have audio CDs available for purchase. Proceedings taken by an Official Court Reporter do not have audio recordings available for sale. Proceedings that were audio recorded and have the certified transcript already filed in the official court file are not available for sale.

Completion. Complete Items 1-19. Do *not* complete shaded areas which are reserved for the court's use.

Order Copy. Keep a copy for your records.

Submitting to the Court. Email the form directly to the court at Services@nvd.uscourts.gov.

Deposit Fee. For orders of 20 or more audio recordings, the court will notify you of the amount of the required deposit fee which may be mailed or delivered to the court. Upon receipt of the deosit, the court will process the order.

Delivery Time. Delivery time is computed from the date of receipt of the deposit fee, if requested, otherwise computed from the court's receipt date.

Completion of Order. The court will notify you when the audio recordings are completed.

Balance Due. If the deposit fee was insufficient to cover all charges, the court will notify you of the balance due which must be paid prior to receiving the completed order.

SPECIFIC

Items 1-19. These items should always be completed.

Item 8. Only one case number may be listed per order.

Item 15. Place an "X" in each box that applies.

Item 16. Check the specific portion(s) and list the specific date(s) of the proceedings for which a copy is requested.

Item 17. Place an "X" in each box that applies. Indicate the number of additional copies ordered.

Item 18. Sign in this space to certify that you will pay all charges upon completion of the order. This includes the deposit plus any additional charges.

Item 19. Enter the date of signing.
